FACTORY AND WORKSHOP ACT, 1901.

The Home Secretary hereby gives notice, in pursuance of Section 80 of the Factory and Workshop Act, 1901, that he has certified the following processes incidental to the manufacture of indiarubber, and of articles and goods made wholly or partially of indiarubber, viz.:
