expire on 31st March, 1921, they again propose to vary the General Minimum Time-Rates and the General Minimum Piece-Rates set out in the Notice, dated 1st March, 1918, by providing that the minimum rates set out in the said Notice dated 1st October, 1920, shall be continued in operation after the 31st March, 1921, subject to the variation of the General Minimum Piece-Rates for making from Iron of § and 13 diameter, respectively, Dollied or Tommied Short Link Chain, or Short Link Hand Hammered Chain, as follows:—

(b) Where the worker provides (in respect of iron provided by the employer) the workshop where the work is carried on and the tools and the fuel or any one of these three heads of outlay:—

For §", from 29s. 7d. per cwt. to 33s. 3d. per cwt.

For $\frac{1}{3}\frac{3}{3}$, from 23s. 9d. per cwt. to 26s. 9d.

UNEMPLOYMENT INSURANCE ACT, 1920.

THE UNEMPLOYMENT INSURANCE (ASSOCIA-TIONS) (SUPPLEMENTARY) REGULATIONS, 1920.

The Minister of Labour, by virtue of the powers conferred on him by the Unemployment Insurance Act, 1920, hereby makes the follow-

ing Regulations:—

1. An arrangement made by the Minister of Labour under Section 105 of the National Insurance Act, 1911, shall, if the Minister of Labour and the Association with which the arrangement was made so agree, and subject to such modifications as may be required, be continued in force on and after the 31st December, 1920, but not after the 28th February, 1921, and, so long as it is so continued, shall be

deemed to be an arrangement under Section 17 of the Unemployment Insurance Act, 1920.

2. These Regulations may be cited as the Unemployment Insurance (Associations) (Supplementary) Regulations, 1920.
