**GAS REGULATION ACT, 1920 (10 AND 11  
Geo. 5, c. 28).**

Order of the Board of Trade, under Section 7 of the Gas Regulation Act, 1920, prescribing the rate of contribution to the Gas Fund for the year 1921.

In pursuance of the powers conferred upon them by Section 7 of the Gas Regulation Act, 1920, the Board of Trade hereby prescribe that:—

1. The rate of contribution to the Gas Fund for the year 1921 shall be three shillings for each million cubic feet of gas sold during the year 1920.

2. Such contribution shall, on or before the 1st April, 1921, be paid to the Board of Trade at Great George Street, London, S.W. 1, by any Gas Undertakers with respect to whom an Order under the said Act shall have been made, by cheque made payable to the "Assistant Secretary for Finance, Board of Trade," and crossed "Gas Fund Account."

**TRADE BOARDS ACTS, 1909 AND 1918.**

**NOTICE OF INTENTION TO MAKE A SPECIAL ORDER, TO BE CITED AS THE TRADE BOARDS (MEAT DISTRIBUTIVE) ORDER, 1921.**

The Minister of Labour hereby gives notice that he intends, pursuant to the powers conferred upon him by Section 1 of the Trade Boards Act, 1918, to make a Special Order applying the Trade Boards Acts, 1909 and 1918, to the trade specified in the appendix to this Notice, and to vary the Trade Boards Provisional Orders Confirmation Act, 1913, confirming, among other Orders, the Trade Boards (Sugar Confectionery and Food Preserving) Order, 1913, and the Trade Boards (Grocery and Provisions) Order, 1920, by the exclusion therefrom of any processes or operations comprised therein, which are included in the appendix to this Notice.

Copies of the Draft Special Order may be obtained on application in writing to the Secretary, Ministry of Labour, Montagu House, Whitehall, London, S.W. 1.

Objections to the Draft Special Order must be sent to the above address within forty-two days from the 14th January, 1921.

Every objection must be in writing, and must state—

- (a) the specific grounds for objection; and
- (b) the omissions, additions or modifications asked for.

#### APPENDIX.

*The Meat Distributive Trade,* that is to say:—

1. The wholesale or retail sale for human consumption off the premises of any one or more of the commodities specified in the Schedule hereto, or the operations of slaughtering or dressing the animals from which any such commodities are obtained, when such sale or operations is or are carried on in or in association with or in conjunction with any business or establishment or branch or department in which the workers are mainly engaged in such sale or operations;

2. The wholesale or retail sale of any goods when carried on in or in association with or in conjunction with any business or establishment or branch or department of the kind specified in paragraph 1 above.

*Including:—*

(a) The operations of cold-storing or refrigerating when carried on in association with or in conjunction with the retail sale specified in paragraph 1 above by workers directly employed by employers engaged in any sale or operation specified in that paragraph;

(b) The cooking, preparing or serving of food or drink for consumption by the public.
