The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as

1.—(i) The Area described in the Schedule hereto is hereby declared to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(ii) Part III. of that Order is hereby applied to such parts of the Scheduled District which includes the said Prohibited Area as are not within the Prohibited Area.

(iii) The provisions of Article 2 of the Grimsby (Foot-and-Mouth Disease) Order of 1920 shall continue to apply to the Prohibited Area, and the provisions of Article 6 of the "principal Order" shall be read and have

effect subject to this modification.

2. This Order shall come into operation on the thirteenth day of January, nineteen hun-

dred and twenty-one.

GLOUCESTER (FOOT-AND-MOUTH DISEASE) ORDER OF 1921.

The Minister of Agriculture and Fisheries. by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:-

Application of Parts I. and IV. of Foot-and-Mouth Disease (Control of Movement) Order of 1920 to Scheduled District.

(1) Parts I. and IV. of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as "the Principal Order," are hereby applied, subject to the modification hereinafter contained, to the district described in the First Schedule hereto. which shall be a Scheduled District for the purposes of that Order and this Order.

## Movement within Scheduled District.

(2) (1) Where an Inspector of the Ministry considers it necessary or expedient after inquiry that an animal in a Scheduled District should be permitted to be moved within a scheduled District as often as occasion may require between different parts of the same farm, he may-notwithstanding any prohibi-tion of movement contained in the Principal Order—authorise such movement by an Occupation Licence, and the Inspector may insert in the licence such conditions as he may consider necessary or desirable for the purpose of preventing the animals referred to in the licence from coming into contact with any

(2) If, in respect of any animal, the conditions of a licence granted under this Article are not complied with, the owner of the animal and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.
