GAS REGULATION ACT, 1920.

Notice of Application by the British Gas Light Company Limited for an Order under Section I of the Gas Regulation Act, 1920.

NOTICE is hereby given, that the British Gas Light Company Limited (hereinafter referred to as "the Undertakers") have applied to the Board of Trade under the provisions of Section I of the Gas Regulation Act, 1920, for an Order providing for—

(a) the repeal of any enactments or other provisions requiring the Undertakers in respect of their gas undertaking at Norwich, carried on under the British Gas Light Company Limited (Norwich) Acts, 1858 to 1918, to supply gas of any particular calorific value and the substitution therefor of power to charge for thermal units supplied in the form of gas; and

(b) the modification of the statutory or other provisions affecting the charges which may be made by the Undertakers in respect of such undertaking by substituting for the maximum prices per 1,000 cubic feet now authorised with additions to meet increases in the costs or charges of and incidental to the production and supply of gas by the Undertakers since 30th June, 1914, maximum prices per therm (i.e., 100,000 British Thermal Units).

The maximum prices now authorised by the said Acts in respect of the supply of gas by the Undertakers are four shillings and sixpence per 1,000 cubic feet within the city and the county of the city of Norwich and the precincts of the Shire Hall at Norwich and the parish of Cringleford, and five shillings and sixpence per 1,000 cubic feet within the remainder of the limits of supply of the Undertakers, with a proviso that the price per 1,000 cubic feet in any parish, other than the parish of Cringleford, added to the Undertakers' limits under the British Gas Light Company Limited (Norwich) Act, 1918, shall be at all times more by at least sixpence per 1,000 cubic feet than the price for the time being charged by the Undertakers for gas supplied by meter under like circumstances to consumers within the city of Norwich.

The prices which the Undertakers have asked the Board of Trade to substitute for these prices in accordance with paragraph (b) above

are one shilling and sevenpence per therm within the city and the county of the city of Norwich and the precincts of the Shire Hall at Norwich and the parish of Cringleford, and one shilling and ninepence halfpenny per therm within the remainder of the limits of supply of the Undertakers, with a proviso that the price per therm in any parish, other than the parish of Cringleford, added to the Undertakers' limits under the said Act of 1918, shall be at all times more by at least one penny farthing per therm than the price for the time being charged by the Undertakers for gas supplied by meter under like circumstances to consumers within the city of Norwich.

GAS REGULATION ACT, 1920.

Notice of Application by the Prescot Gas Company for an Order under Section I of the Gas Regulation Act, 1920.

NOTICE is hereby given, that the Prescot Gas Company (hereinafter referred to as "the Undertakers") have applied to the Board of Trade under the provisions of Section I of the Gas Regulation Act, 1920, for an Order providing for—

(a) The repeal of any enactments or other provisions requiring the Undertakers to supply gas of any particular calorific value and the substitution therefor of power to charge for thermal units supplied in the form of gas; and

(b) The modification of the statutory or other provisions affecting the charges which may be made by the Undertakers by substituting for the maximum price per 1,000 cubic feet now authorised with an addition to meet increases in the costs and charges of and incidental to the production and supply of gas by the Undertakers since 30th June, 1914, a maximum price per therm (i.e., 100,000 British Thermal Units).

The maximum price now authorised in respect of the supply of gas by the Undertakers is 5s., less 10 per cent., or 4s. 6d. per 1,000 cubic feet, and the price which the Undertakers have asked the Board of Trade to substitute for this price in accordance with paragraph (b) above is 1s. 5d. per therm.
