**ADDITIONAL TREASURY REGULATION UNDER
SECTION 4 OF THE PENSIONS (INCREASE) ACT,
1920, RELATING TO PENSIONERS IN RECEIPT
OF PENSIONS GRANTED BY LOCAL OR OTHER
PUBLIC AUTHORITIES (WITH THE EXCEPTION
OF POLICE AUTHORITIES) IN GREAT BRITAIN.**

Nos. 6 and 7 of the Regulations dated the 11th October, 1920, relating to pensioners in receipt of pensions granted by Local or other Public Authorities (with the exception of Police Authorities) in Great Britain are hereby repealed, and the following shall be substituted therefor:—

6. Where in pursuance of an application an increase of pension is granted, the increase shall continue in force until the expiration of a period of twelve months from the date as from which the increase is payable unless in the meantime the pensioner dies or ceases to fulfil the statutory condi-

tions. Provided that in the case of a first application the increase may, if the Pension Authority think fit and subject to the provisions of the Act, continue in force until the 31st March, 1922.

7. Applications for the continuance and reassessment of increases of pensions, accompanied by a like declaration, shall be sent to the Pension Authority not more than three nor less than two months before the expiration of the first period for which the increase is granted and of every subsequent period of twelve months.

**ORDER MADE BY THE TREASURY UNDER SECTION
3 OF THE PENSIONS (INCREASE) ACT, 1920.**

In pursuance of the powers vested in Us by Section 3 of the Pensions (Increase) Act, 1920, We, being Two of the Lords Commissioners of His Majesty's Treasury, after consultation with the Home Office and the Ministry of Health, hereby declare that the provisions of the Act shall apply—

(a) to pensioners in receipt of pensions or superannuation allowances granted under any of the following enactments:—

The Metropolitan Police Staff Superannuation Acts, 1875 and 1885, as amended by Section 4 of the Police Act, 1909.

The Liverpool Improvement Act, 1882, and the Liverpool Corporation Acts, 1893 and 1913.

The Stepney Borough Council (Superannuation) Act, 1905.

The Camberwell and other Metropolitan Borough Councils (Superannuation) Act, 1908.

The St. Marylebone Borough Council (Superannuation) Act, 1908.

The Westminster City Council (Superannuation and Pensions) Act, 1909

The Wandsworth Borough Council (Superannuation) Act, 1909.

The Poplar Borough Council (Superannuation and Pensions) Act, 1911.

The Paddington Borough Council (Superannuation and Pensions) Act, 1911.

The Chelsea Borough Council (Superannuation and Pensions) Act, 1914.

(b) to pensioners in receipt of pensions granted by a local authority in England or Wales under Section 280 of the Lunacy Act, 1890, and

(c) to former officers of the Cardiff Fire Brigade in receipt of pensions granted under the Cardiff Corporation Act, 1894.
