## CORN PRODUCTION ACTS, 1917 AND 1920.

## AGRICULTURAL WAGES DISTRICT COMMITTEES IN WALES.

1. The Ministry of Agriculture and Fisheries hereby divides Wales (including Monmouthshire), for the purposes of the Second Schedule to the Corn Production Act, 1917, as applied to Wales by the Agriculture Act, 1920, into the six districts described in the Schedule to this Order and fixes the same accordingly.

2. On or after the first day of April, nineteen hundred and twenty-one, the Minister, if satisfied that in any district fixed by this Order there does not then exist a representative joint committee comprising a chairman and representatives of employers of agricultural labour and of workmen employed in agriculture in equal numbers for purposes which include the fixing of minimum rates of wages for workmen employed in agriculture, will proceed to nominate a joint committee constituted as aforesaid for the district.

In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this tenth day of March, nineteen hundred and twenty-one.

## SCHEDULE.

*Agricultural Wages Districts.*

1. Glamorgan and Monmouth District, comprising the administrative counties of Glamorgan and Monmouth and the county boroughs of Cardiff, Merthyr Tydfil, Newport and Swansea.

2. Pembroke, Carmarthen and Cardigan District, comprising the administrative counties of Pembroke, Carmarthen and Cardigan.

3. Radnor and Brecon District, comprising the administrative counties of Radnor and Brecon.

4. Anglesey and Carnarvon District, comprising the administrative county of Anglesey and the administrative county of Carnarvon except the parish of Llysfaen.

5. Denbigh and Flint District, comprising the administrative counties of Denbigh and Flint and the parish of Llysfaen in the administrative county of Carnarvon.

6. Merioneth and Montgomery District, comprising the administrative counties of Merioneth and Montgomery.

## CORN PRODUCTION ACT, 1917.

AGRICULTURAL WAGES BOARD  
(ENGLAND AND WALES).NOTICE OF PROPOSAL TO VARY THE DEFINITION  
OF A CERTAIN CLASS OF WORKER IN  
NORTHUMBERLAND AND DURHAM.

The Agricultural Wages Board (England and Wales) hereby give notice, as required by the above Act, that they propose to vary their Orders of the 13th August, 1920, and the 21st January, 1921, so far as those Orders relate to the area of the District Wages Committee for Northumberland and Durham, by substituting in the Schedule to each of those Orders for the words "workmen employed as whole-time shepherds or wholly in tending sheep" the words "workmen of the said ages employed wholly or mainly as shepherds."

The Agricultural Wages Board, as required by the above Act, will consider any objections to the above Proposal which may be lodged with them within one month from the date of this notice. All objections should be in writing, and should be addressed to the Secretary, Agricultural Wages Board (England and Wales), 80, Pall Mall, London, S.W. 1. The objections should state precisely and with reasons what is objected to.
