

under this regulation as respects any local authority whose duty it is to supply money to defray or aid in defraying the expenses of another local authority (hereinafter referred to as the 'dependent authority') and in consequence of the order a deficiency arises in the funds of the dependent authority, the Local Government Board for Ireland may, for the purpose of enabling the dependent authority to provide for their current expenses, authorize the dependent authority to borrow by way of temporary loan or overdraft from any bank such sums, upon such security and for such period as the Board may approve."

WHEREAS by an Order in Council, dated the twenty-eighth day of November, nineteen hundred and fourteen, His Majesty was pleased to make regulations (called "the Defence of the Realm Regulations") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm; which regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient that the regulation hereinafter mentioned should cease to have effect:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that Regulation 9G shall, as from the first day of April, nineteen hundred and twenty-one, be revoked.

WHEREAS by the Summer Time Act, 1916, as amended by the Time (Ireland) Act, 1916, and by the War Emergency Laws (Continuance) Act, 1920, it is provided that during the prescribed period in each year in which the first-named Act is in force the time for general purposes is to be one hour in advance of Greenwich Mean Time; and it is further provided that His Majesty may, in any year subsequent to the year 1916, by Order in Council, made during the continuance of the present War and a period of twelve months after the termination thereof, declare the said Act to be in force during that year, and in such

case the prescribed period for that year shall be such period as may be fixed by Order in Council:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to declare, and it is hereby declared, that the Summer Time Act, 1916, as so amended as aforesaid, shall be in force during the year 1921, and the prescribed period in that year shall be from two o'clock in the morning Greenwich Mean Time on Sunday, the 3rd day of April, until two o'clock in the morning Greenwich Mean Time on Monday, the 3rd day of October.

WHEREAS by Section 393 of the Merchant Shipping Act, 1894, it is (amongst other things) enacted that a boy under the age of sixteen years shall not be taken to sea for the purpose of serving in any capacity connected with the sea-fishing service unless he is bound by an Indenture of Apprenticeship or Agreement made in conformity with Part IV of the said Act:

And whereas by Section 395 of the same Act it is (amongst other things) enacted that Indentures of Apprenticeship to the sea-fishing service and Agreements with boys under the age of sixteen years with respect to that service shall be in such form and contain such covenants, provisions, stipulations, endorsements, and certificates as are prescribed by Order in Council made on the recommendation of the Board of Trade, and that any directions given in the forms so prescribed shall be complied with:

And whereas by Order in Council made on the recommendation of the Board of Trade, dated the 12th day of December, 1894, it was, among other things, ordered and prescribed that on and after the 1st day of January, 1895, Indentures of Apprenticeship to the sea-fishing service should be in the form set forth in the Schedule thereto, and should contain the covenants, provisions, stipulations, endorsements, and certificates therein mentioned with respect to the said Indentures:

And whereas by an Order in Council made on the recommendation of the Board of Trade, dated the 19th day of October, 1908, it was ordered and prescribed that on and after the 1st day of November, 1908, any Indentures of Apprenticeship to the sea-fishing service made before the Superintendent at the Port of Grimsby should either be in the form set forth in the Schedule to the said Order in Council, dated the 12th December, 1894, and contain the covenants, provisions, stipulations, endorsements, and certificates in the said Schedule mentioned with respect to Indentures of Apprenticeship to the sea-fishing service, or be in the form set forth in the Schedule to the Order in Council now being recited, and should contain the covenants, provisions, stipulations, endorsements, and certificates therein mentioned:
