Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said Bertram, Bishop of Norwich, has executed this Scheme as hereinafter mentioned:

And whereas the transfer of the Patronage of the said Benefice of Stockton which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that

is to say, in the Parish of Stockton:

"Now, therefore, with the consent of the said John Gill (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Bertram, Bishop of Norwich (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Stockton, now vested in him the said John Gill as aforesaid, shall be transferred to the said Bertram, Bishop of Norwich, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Bertram, Bishop of Norwich, and by his successors in the same Bishopric for

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Regis-

trar of the said Diocese of Norwich.

The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 20th day of January, 1921, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme with respect to the Archdeaconries of Richmond and Ripon, in the Diocese of Ripon, and also with respect to the name of the said Archdeaconry of Ripon:
"Whereas by an Order of Her said late

Majesty in Council bearing date the 23rd day of August, 1894, and published in the London Gazette on the 31st day of the same month, there was created a new Archdeaconry within the said Diocese of Ripon which was named the

Archdeaconry of Ripon':

"And whereas by an Order of Your Majesty in Council bearing date the 26th day of April, 1920, and published in the London Gazette on the 30th day of the same month, the main portion of the Rural Deanery of Otley was assigned to the newly constituted Diocese of Bradford, but certain Parishes theretofore in that Rural Deanery were retained in the Diocese of

Ripon: And whereas it has been represented to us by the Right Reverend Thomas Banks, Bishop of Ripon, first, that the arrangements which are hereinafter recommended and proposed with respect to the said Archdeaconries of Richmond and Ripon are desirable and should be carried, into effect; and secondly, that in the event of such arrangements being effected a change in the name of the said Archdeaconry of Ripon is also desirable and should be carried into effect, and we are of opinion that the same may properly be carried into effect:

"Now, therefore, with the consent of the said Thomas Banks, Bishop of Ripon (in testimony whereof he has set his hand and espiscopal seal to this Scheme) we, the said Ecclesiastical Commissioners, humbly recommend and propose that, as from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order, first, the Rural Deanery of Ripon, in the said Archdeaconry of Ripon, shall be transferred from such Archdeaconry and shall be included in the said Archdeaconry of Richmond, and shall be subject to the jurisdiction and authority of the Archdeacon of such Archdeaconry; secondly, the Parishes of Horsforth and Woodside, formerly in the said Rural Deanery of Otley, shall be included in the Rural Deanery of Leeds, the Parishes of Saint Peter, Arthington; Saint Giles, Bramhope; Saint Wilfred, Pool; Stainburn; and Saint Barnabas, Weeton, formerly in the said Rural Deanery of Otley shall be included in the Rural Deanery of Knaresborough, and the Parishes of Pannal and Saint Michael and All Angels, Beckwithshaw, at present in the Rural Deanery of Wetherby shall be transferred to
