# NATIONAL HEALTH INSURANCE ACTS, 1911 to 1920.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 4 (2) of the National Health Insurance Act, 1920, to make regulations prescribing the manner in which any surplus standing to the credit of the Sanatorium Benefit Fund of any Insurance Committee on the 30th April, 1921, after all liabilities in respect of the expenses of sanatorium benefit have been met, is to be disposed of, the manner in which any deficit in such Fund is to be met, making such other financial adjustments as appear necessary for the termination of sanatorium benefit, determining any agreements entered into by Insurance Committees relating to sanatorium benefit and prescribing the conditions on which the rights or liabilities under any such agreement may be transferred to other persons.
