

Council, prohibit the exportation from the United Kingdom of arms, ammunition, and gunpowder, military and naval stores, and any articles which His Majesty shall judge capable of being converted into or made useful in increasing the quantity of military or naval stores, provisions, or any sort of victual which may be used as food for man:

And whereas it is expedient to prohibit the exportation of the articles hereinafter enumerated:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

As from the date of this Order the following articles shall be, and the same are hereby, prohibited to be exported from the United Kingdom:—

1. Cannon and other ordnance and component parts thereof;

2. Carriages and mountings for cannon and other ordnance and component parts thereof;

3. Cartridges, charges of all kinds, and component parts thereof;

4. Explosives, except the following:—

Blasting Gelatine;

Gelignite;

Gelatine Dynamite;

Viking Powder;

Detonators;

Electric Detonators;

Monobel;

Safety Fuses;

Dynamite;

Rex Powder;

Fireworks;

Amoroes;

Fog Signals;

Bonbons;

5. Firearms and component parts thereof;

6. Grenades and component parts thereof;

7. Machine guns, interrupter gears, mountings for machine guns and component parts thereof;

8. Projectiles of all kinds (except air-gun pellets) and component parts thereof;

9. Mines, land or sea, and component parts thereof;

10. Depth charges and component parts thereof;

11. Bombs, bombing apparatus, and component parts thereof;

12. Flame-throwers and component parts thereof;

13. Fuses (other than safety fuses) and component parts thereof;

14. Torpedoes and component parts thereof;

15. Torpedo tubes, or other apparatus for discharging torpedoes.

Provided always, and it is hereby declared, that this Order shall not apply to any exportation which shall be expressly permitted by a licence given by the Board of Trade and in accordance with the conditions (if any) of such licence.

WHEREAS it is expedient that the Royal Air Force shall use and employ a distinguishing ensign:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. The following ensign is hereby established and shall be recognised as the colours of the Royal Air Force, that is to say: of light blue, in the dexter canton the Union, and in the centre of the fly of the flag three roundles superimposed, red upon white upon blue; and the said ensign shall be flown in such manner and on such occasions only as may from time to time be ordered by the Air Council.

2. This Order may be cited as the Royal Air Force Ensign Order, 1921.

WHEREAS by Section 13 of the Air Force (Constitution) Act, 1917, it is provided that His Majesty may by Order in Council apply, with the necessary modifications and adaptations, in relation to the Air Council, the President of the Air Council, and the Air Force and the officers and men thereof, and Air Force property or institutions, any of the enactments relating to the Army Council, the Secretary of State for the War Department, the Army or the officers and soldiers thereof (including enactments conferring any powers, rights, exemption or abatement from taxation or immunities or imposing any duties or disabilities on any such officers or soldiers) or to military property or institutions:

And whereas, by certain Orders made under the said section certain enactments have been applied in relation as aforesaid, and it is expedient to apply the further enactments mentioned in the first column of the Schedule to this Order:

And whereas the provisions of Section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

1. The enactments mentioned in the first column of the Schedule to this Order, being enactments relating to the Army or the officers and soldiers thereof, shall apply in relation to the Air Force and the officers and airmen thereof, subject to the modifications and adaptations specified in the second column of that Schedule.

2. This Order may be cited as the Air Force (Application of Enactments) Order, 1921.
