#### BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Conrad Hermann Holm.  
Revocation of Certificate of Naturalisation.

Whereas I am satisfied that the Certificate of Naturalisation, numbered A2694, granted to Conrad Hermann Holm on the 30th August, 1878, is revocable under the provisions of Section 7 (2) (d) of the British Nationality and Status of Aliens Act, 1914, and that the continuance of the certificate is not conducive to the public good.

Now, therefore, by this Order, made in pursuance of the powers conferred upon me by Section 7 of the British Nationality and Status of Aliens Act, 1914, I revoke the said certificate, and I direct such revocation to have effect from the date hereof, and I further order the said certificate to be given up and to be cancelled.

And I further direct that the wife of the said Conrad Hermann Holm shall cease to be a British subject.
