##### JUTE TRADE BOARD. (GREAT BRITAIN.)

##### PROPOSAL TO FIX GENERAL MINIMUM PIECE-RATES FOR CERTAIN CLASSES OF FEMALE WEAVERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October, 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Jute trade as specified in the Trade Boards (Jute) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to fix General Minimum Piece-Rates for certain classes of Female Weavers.

The Proposed General Minimum Piece-Rates shall apply to the weaving of all Hessian, floor-cloth and linoleum goods in ordinary Hessian looms as generally existing in Dundee at the date of this Notice, but shall not apply to cloth woven in looms the reed space of which is 32 inches or narrower.

Full information with regard to the actual Piece-Rates and the conditions of their application may be obtained from the Secretary of the Jute Trade Board (Great Britain), at the address given below.

The Trade Board will consider any Objections to their Proposals to Fix which may be lodged with them within two months from 11th April, 1921. Such Objections should be in writing, and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Jute Trade Board (Great Britain), 7-11, Old Bailey, London, E.C. 4.
