## THE MOTOR CAR ACT, 1903.

## BOROUGH OF BLACKPOOL.

Whereas by sub-section (1) of Section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas by virtue of the Ministry of Transport Act, 1919, and Orders in Council made thereunder, the power to make such regulations has been transferred to the Minister of Transport;

And whereas the Council of the Borough of Blackpool have made application to the Minister of Transport for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits compris-

ing the following roads or parts of roads within the Borough, that is to say:—

Carriageway (Promenade), from the Gynn to the Pleasure Beach; Lytham Road, from the Promenade to Squires Gate Lane; Central Drive, from Hounds Hill to Waterloo Road; St. Anne's Road, from Waterloo Road to Squires Gate Lane; Waterloo Road, from the Promenade to Preston New Road; Whitegate Drive, from Preston New Road to Raikes Road; New Road, from Swainson Street to Grange Road; and Westcliffe Drive, from Grange Road to Brooklyn Avenue;

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 7th day of September, 1920, and in the Blackpool Gazette and Herald of the 7th day of September, 1920;

And whereas certain objections to the making of any regulation in pursuance of the said provisions have been received by the Minister of Transport, and it is expedient that further inquiry should be made in the matter of the said application:

Notice is hereby given that F. C. Cook, Esquire, D.S.O., M.C., M.Inst.C.E., one of the Inspectors of the Ministry of Transport, will attend at the Town Hall, Blackpool, on Tuesday, the tenth day of May, 1921, at ten o'clock in the forenoon, to hold a Local Inquiry into the subject-matter of the said application:

And notice is hereby further given that any person interested may attend at such Inquiry, and be heard with reference to the said application.
