DAY INDUSTRIAL SCHOOLS.

REGULATIONS OF THE SECRETARY OF STATE, DATED 31ST MAY, 1921, AS TO PARENTAL CON-TRIBUTIONS AND ATTENDANCE AT SCHOOL IN CASES UNDER SECTION 79 OF THE CHILDREN Act, 1908 (8 Edw. 7, c. 67).

In pursuance of section seventy-nine of the Children Act, 1908, I hereby make the following Regulations:-

1. In the case of a child sent to a Certified Day Industrial School under an Attendance Order or without an Order of Court, the sum which his parent shall undertake to pay towards the industrial training and meals of such child shall be such sum as may be agreed upon between the parent of the child and the Managers of the School, not exceeding the sum of 5s. a week.

2. The attendance of a child at a Certified Day Industrial School shall not be reckoned unless it includes at least three hours of secular instruction.

3. The regulations made by the Secretary of State for the Home Department on the same subject, on the 29th March, 1909, are hereby .cancelled.
