

Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Saint Thomas, Woolwich, in the County of Kent and in the Diocese of Southwark:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Thomas, Woolwich, stands limited to the use of certain Trustees for a term of years and subject thereto to the use of Sir Spencer Pocklington Maryon Maryon-Wilson, Baronet, of Eastborne, of Bury Hill, Dorking, in the County of Surrey, during his life and the said Sir Spencer Pocklington Maryon Maryon-Wilson, Baronet, is the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said Sir Spencer Pocklington Maryon Maryon-Wilson, Baronet, is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Thomas, Woolwich, should be transferred to and be vested in the Right Reverend Cyril Forster, now Bishop of Southwark, and his successors in the same Bishopric:

"And whereas the said Cyril Forster, Bishop of Southwark, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Cyril Forster, Bishop of Southwark, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Saint Thomas, Woolwich, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the New Parish of Saint Thomas, Woolwich:

"Now, therefore, with the consent of the said Sir Spencer Pocklington Maryon Maryon-Wilson, Baronet, being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts and of the Act of the 1st and 2nd years of Her said late Majesty, Chapter 106 (in testimony of which consent he has signed and sealed this Scheme), and with the consent of the said Cyril Forster, Bishop of Southwark (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Thomas, Woolwich, shall be transferred to the said Cyril Forster, Bishop of Southwark, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Cyril Forster, Bishop of Southwark, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwark.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty, Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 12th day of May, 1921, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty, Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Christ Church, Fenton, the New Parish of Saint John the Baptist, Lane End, and the New Parish of Saint Jude, Hanley, all in the County of Stafford and in the Diocese of Lichfield:

"Whereas by an Instrument bearing date the 7th day of May, 1860, and being under the hand and seal of the then Bishop of the said Diocese of Lichfield and being also under the hand and seal of the Rector or Incumbent of the Rectory of the Parish of Stoke upon Trent, in the said County and Diocese, a separate District was assigned to the consecrated Church called Christ Church, situate at Fenton Calvert otherwise Great Fenton in the said Parish of Stoke upon Trent, and the same was called 'The Particular District of Christ Church, Fenton':

"And whereas by the authority of an Order of Her said late Majesty in Council, bearing date the 3rd day of February, 1866, and published in the London Gazette on the 6th day of the same month, part of the District Parish of Longton, in the said County and Diocese, was assigned as a District Chapelry to the consecrated Church of Saint John the Baptist, situate at Lane End in the said District Parish
