RAILWAYS (IRELAND) ACT, 1896.

LONDONDERRY AND LOUGH SWILLY (LETTERKENNY TO BURTON PORT EXTENSION) RAILWAY.

To all whom it may concern.

Whereas it was reported to the Board of Works pursuant to Section 7 of the Railways (Ireland) Act, 1896, that the Undertaking known as the Londonderry and Lough Swilly (Letterkenny to Burton Port Extension) Railway has not been efficiently worked, maintained, and developed, and the Board of Works made a report to the Lord Lieutenant, and whereas, after consideration of the said report, the Lord Lieutenant and Privy Council and the Lords Justices and Privy Council were pleased, by Orders dated 4th July, 1917, 29th April, 1918, and 27th June, 1919, to appoint a Manager of the said Undertaking for a period of four years from the 1st July, 1917, subject to the conditions specified in such Orders.

And whereas the powers and duties of the Lord Lieutenant and Privy Council, in relation to Railways under the Railways (Ireland) Act, 1896, have been transferred to and are now vested in the Minister of Transport, and the Board of Works have made application to the said Minister for an Order extending for a period of two years the operation of the provisions of the said Orders of the 4th July, 1917, 29th April, 1918, and 27th June, 1919.

Notice is hereby given, that the Minister of Transport, after giving all the persons interested an opportunity of being heard, will consider the making of the further Order appointing a Manager or Receiver of the Undertaking for such time and with such powers as may be specified in the Order.

And that Wednesday, the 22nd day of June, 1921, at the hour of 11 o'clock a.m., and thereafter as may be necessary, has been fixed for the consideration of the said application of the Board of Works, and that all persons interested and entitled to be heard may appear in person or by Council at the time so appointed.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 15TH JUNE 1921.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows :—

Movement of Swine otherwise than for Breeding Purposes.

1.—(1) Swine shall not except as hereinafter provided be moved from premises situate in any
