BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Karl Georg Sylvester Schaeffer.

Revocation of Certificate of Naturalization.

Whereas Karl Georg Sylvester Schaeffer, having during infancy become resident in the United Kingdom with his father, Georg Sylvester Schaeffer, who obtained a Certificate of Naturalization in the United Kingdom, on 25th April, 1893, has been deemed to be a naturalized British subject, in pursuance of section 10 (5) of the Naturalization Act, 1870; and

Whereas in pursuance of section 27 (2) of the British Nationality and Status of Aliens Act, 1914, as amended, the said Karl Georg Sylvester Schaeffer is deemed for the purposes of that Act, to be a person to whom a Certificate of Naturalization has been granted; and

Whereas I am satisfied that the said Karl Georg Sylvester Schaeffer has, since the 25th April, 1893, been for a period of not less than seven years ordinarily resident out of His Majesty's Dominions, otherwise than as a representative of a British subject, firm or company carrying on business, or an institution established in His Majesty's dominions, or in the service of the Crown, and has not maintained substantial connection with His Majesty's dominions; and that the continuance of the certificate is not conducive to the public good;

Now, therefore, by this Order, made in pursuance of the powers conferred upon me by Section 7 of the British Nationality and Status of Aliens Act, 1914, I revoke the certificate granted to Karl Georg Sylvester Schaeffer, and I direct such revocation to have effect from the date hereof.

The Home Secretary gives notice that, in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment of women of 18 years of age and over in carding, spinning and doubling of asbestos at the works of Bell's United Asbestos Co., Ltd., Harefield, Middlesex, on two day-shifts, subject to the conditions that no worker shall be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
