BUSINESS NAMES.

THE BUSINESS NAMES RULES, 1921, AS TO FEES, DATED 6TH JUNE, 1921, MADE BY THE BOARD OF TRADE, WITH THE CONCURRENCE OF THE TREASURY, PURSUANT TO SECTION 17 OF THE REGISTRATION OF BUSINESS NAMES ACT, 1916 (6 AND 7 GEO. 5, c. 58).

1. The following Rule shall be substituted for Rule 11 of the Business Names Rules, 1917:---

Fees.

11. The fees to be paid to the Registrar under the Act are to be as follows:---

(a) On a Statement of Particulars required by Section 3 of the Act the sum of five shillings, and such fee shall cover the issue of one certificate of registration.

(b) On any Statement of Particulars required by the Schedule to the Act when such particulars are not furnished with the Statement of Particulars required by Section 3 of the Act the sum of five shillings, and such fee shall cover the issue of one certificate of registration.

(c) On a statement of any change within the meaning of Section 6 of the Act the sum of five shillings, and such fee shall cover the issue of one certificate of the registration of such statement.

(d) By any person inspecting under the provisions of Section 16 of the Act the documents filed by the Registrar, the sum of one shilling for each inspection.

(e) On the application of any person requiring under the provisions of Section 16 of the Act a certificate of registration of any firm, individual or corporation or a certified copy of or extract from any registered statement the sum of two shillings for a certificate of registration, and for each certified copy or extract the sum of sixpence for each folio of seventy-two words, or in Scotland for each sheet of two hundred words.

(f) By any person appealing to the Board of Trade from a decision of the Registrar the sum of one pound.

2. These Rules may be cited as the Business Names Rules, 1921, and shall come into operation on the first day of July, 1921.
