in Holy Orders appointed by the Governing Body.

CHAPTER XXVII.

Of Repeal of Statutes.

From the date on which these Statutes shall take effect, all the Statutes of the College in force before that time shall be repealed, save and except the ten Statutes for the future regulation of the several Bye-Foundations approved by the Queen in Council on the 16th April, 1861. Provided that if the Master or any Fellow elected before the confirmation of these Statutes by His Majesty the King in Council shall elect to remain under the operation of the previously existing Statutes, it shall be lawful for him within one year after such confirmation to signify such election by writing under his hand to the Governing Body of the College, when his rights shall be considered to have been preserved in all respects, and shall continue to be governed by those Statutes.

CHAPTER XXVIII.

Of the Benefactions of Mr. Edward Montagu and Dr. Micklethwaite.

Notwithstanding any provisions contained in the Statutes for Mr. Edward Montagu's Scholarships and Dr. Micklethwaite's Scholarships, approved as aforesaid by the Queen in Council on the sixteenth day of April, 1861, all the emoluments derived by the College from the benefactions of the said Mr. Edward Montagu and Dr. Micklethwaite shall be consolidated and carried to the General Fund of the College to be applied in the manner directed by the Statutes of the College.

CHAPTER XXIX.

Of Construction of Statutes.

Any question which may arise as to the construction or operation of these Statutes shall be decided by a College Meeting specially summoned by the Master, who shall send notice of such Meeting to all the Fellows at least six days before the date fixed for the Meeting. Provided that the Master or any two of the Fellows may within six months appeal against such decision to the Visitor, whose judgment thereon shall be final:

The following Statute, made by the Governing Body of All Souls College, Oxford, on the 30th day of April. 1921, and sealed on the 18th day of June, 1921, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877":—

Whereas the University of Oxford Commissioners, under and by virtue of all and every the powers in that behalf enabling them contained in the Universities of Oxford and Cambridge Act, 1877, did, by an Instrument under their Seal, dated the 16th day of June, 1881, make certain Statutes thereunto annexed for your Petitioners, who are therein described as the College of All Souls of the Faithful Departed, commonly called All Souls College, in the University of Oxford.

And whereas such Statutes were approved by her late Majesty Queen Victoria in Council, on the 3rd day of May, 1882, and have since been altered and amended from time to time.

And whereas at a General Meeting of the Governing Body of our said College, specially summoned for that purpose, and held on the 30th day of April, 1921, it was unanimously resolved, by those present and voting at the Meeting, that the further alteration in the said Statutes hereinafter specified should be made, that is to say:—

In Statute VIII. (April, 1913, Edition).

Clause 3 (Table Allowance) shall be repealed, and there shall be substituted therefor a new Clause 3, and to be in the words and figures following namely:—

following, namely:—
3. The Warden and Fellows may, if they think fit, set apart sums not exceeding the following sums in respect of the Warden and each Fellow or Honorary Fellow for the expenses of his breakfast, luncheon or dinner on each day when he shall breakfast, lunch or dine at the Common College Meal, whether in Hall or in some public room of the College:—

For breakfast, two shillings per diem. For luncheon, two shillings per diem. For dinner, four shillings per diem.

Now, we, the said Warden and College, in pursuance of the provisions of the said Universities of Oxford and Cambridge Act, 1877, do hereby submit the aforesaid alteration, made by us in the Statutes governing our said College to the King's Most Excellent Majesty in Council, and humbly pray that the same may be approved and confirmed.
