

sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint John the Baptist, Leeming, shall be altered so that all that portion of the said Parish of Burneston which is described in the Schedule hereunder written and is delineated and set forth upon the Map or Plan hereunto annexed and is thereon coloured pink shall be dis severed from such Parish and shall be annexed to and shall in future form part of the said New Parish of Saint John the Baptist, Leeming.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid, or any of them in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the New Parish of Saint John the Baptist, Leeming, in the County of York and in the Diocese of Ripon, being:—

"All that portion of the Parish of Burneston, in the said County and Diocese, which is bounded upon the north-east and upon the north-west by the said New Parish of Saint John the Baptist, Leeming, upon the west partly by the Parish of Bedale and partly by the Parish of Well, both in the said County and Diocese, and upon the remaining side, that is to say, upon the south-east, by an imaginary line commencing at the point where the boundary which divides the said Parish of Well from the said Parish of Burneston meets the boundary which divides the Civil Parish of Theakston from the Civil Parish of Exelby, Leeming and Newton, and extending thence first north-eastward, and then in various directions along the said civil parish boundary for a distance of 70 chains or thereabouts to the point where it crosses the middle of the road leading from Burneston to Exelby, and extending thence north-westward along the middle of the said road for a distance of 6 chains or thereabouts to a point opposite to the fence forming the southern boundary of the close numbered 1 upon the Map or Plan annexed to this Scheme or Representation, and extending thence north-eastward to and along the said fence for a distance of 18 chains or thereabouts to its eastern end, and continuing thence in the same direction and in a straight line for a distance of 1½ chains or thereabouts to the boundary which divides the said Parish of Burneston from the said New Parish of Saint John the Baptist, Leeming."

"And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto:

"And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with

the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Ripon.

The following Statute made by the Governing Body of Corpus Christi College, Oxford, on the 12th day of March, 1921, and sealed on the 24th day of March, 1921, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877":—

WHEREAS the President and Scholars being the Governing Body of Corpus Christi College in the University of Oxford, did under the provisions of the Universities of Oxford and Cambridge Act, 1877, on the twelfth day of March, One thousand nine hundred and twenty-one, at a General Meeting specially summoned for the purpose by votes of not less than two-thirds of the number of persons present and voting repeal Statute 77 (3) β of the Statutes of the College.

Now, therefore, the said President and Scholars, being the Governing Body of Corpus Christi College, in the University of Oxford, do humbly submit the above-mentioned amending Statute to His Majesty the King in Council, and pray that He will be pleased, by and with the advice of His Privy Council, to declare His approval of the same.

In the Statutes made for Corpus Christi College, Oxford, by the University of Oxford Commissioners and approved by Her late Majesty Queen Victoria in Council on the third day of May, 1882: In Statute 77 (3) the Section "β," "The filling up from time to time of one Extraordinary Fellowship under Clause 22," shall be repealed, and the next Section "γ" shall hereafter become the Section "β."
