authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

Section II.—The above Proposed Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of these Minimum Rates of Wages.

The Trade Board further give notice that the above Proposed Minimum Rates of Wages are in substitution for the proposed minimum rates set out in the Notice G.P.S. (1) dated 14th December, 1920, which is hereby withdrawn

The Trade Board will consider any Objections to the above Proposals to Fix which may be lodged with them within two months from 13th August, 1921.
