W HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 5th day of August, 1921 (N.P. (4) 1491/20), in the words following,

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 20th March 1891, to sanction payment of an allowance of is. a day to certain ratings of the Writer Branch when serving in ships not

allowed an Officer of the Accountant Branch:
"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 27th May, 1921, to sanction payment, under specified conditions, of Captain's Clerk Allowance to ratings of the Writer Branch of

Your Majesty's Navy:

"And whereas we are of opinion that it is desirable to extend payment of these allowances to ratings of the Victualling Branch when carrying out the combined duties of Writer and Victualling rating, subject to the provisos that the allowances shall not be paid concurrently, and that Writers drafted for the performance of the combined duties shall be ineligible to receive Victualling Store Allow-

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the extension of payment of these allowances accordingly

as from the 9th June, 1921. "The Lords Commiss Commissioners of Your Majesty's Treasury have signified their concur-

rence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS by paragraph (c) of sub-section (2) of Section 4 of the Scottish Board of Health Act, 1919, it is provided that His Majesty may by Order in Council transfer to the Scottish Board of Health any powers and duties in Scotland of any Government Department which appear to His Majesty to relate to

the people;

And whereas by sub-section (4) of the said Section it is provided that His Majesty may by Order in Council make such incidental, consequential and supplemental provisions as may be necessary or expedient for the purpose of giving full effect to any transfer of powers or duties by or under that Section and may make such adaptations in the enactments relating to such powers and duties as may be necessary to make exercisable by the Board and the officers thereof the powers and duties so transferred;

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Scottish Board of Health (Factories and Workshops Transfer of Powers) Order, 1921.

(2) The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2.—(1) On and after the date of this Order the powers and duties of the Secretary of State under the Factory and Workshop Act, 1901, so far as they relate to the supervision and enforcement of the provisions of the Sections of that Act set out in the Schedule to this Order, shall be transferred to the Scottish Board of Health.

(2) References to inspectors in the said Act shall, so far as relates to powers and duties conferred and imposed on inspectors with reference to the provisions of the Sections set out in the said Schedule, be deemed to be references to inspectors appointed by the Scottish Board of Health.

3. References to the Scottish Board of Health shall be substituted for references to the Secretary of State in sub-section (5) of Section 110 of the said Act, and in Section 120 of the said Act so far as that Section relates to proceedings for the enforcement of any of the provisions of the Sections set out in the said Schedule.
