

Borough Boundary to Regent Bridge, thence in a westerly direction along the centre of Regent Road to Cross Lane, thence along the centre of Cross Lane to Windsor, thence along the boundary of the Parliamentary Division of South Salford to its intersection with the boundary of Ward 6, thence in a southerly and easterly direction along the boundary of Ward 6 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 8, otherwise Regent Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point in the centre of Regent Road on Regent Bridge over the centre of the River Irwell and passing thence in a south-westerly direction along the County Borough Boundary to a point opposite the centre of Fairbrother Street, thence along the centre of Fairbrother Street to Ordsall Lane, thence in a north-easterly direction along the centre of Ordsall Lane to a point opposite the centre of Braddon Street, thence along the centre of Braddon Street to Oldfield Road, thence in a northerly direction along the centre of Oldfield Road to Robert Hall Street, thence along the centre of Robert Hall Street to Trafford Road, thence in a northerly direction along the centre of Trafford Road to Regent Road, thence in an easterly direction along the boundary of Ward 7 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 9, otherwise Ordsall Park Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point on the County Borough Boundary opposite the centre of Fairbrother Street and passing thence in a south-westerly direction along the County Borough Boundary to the Swing Bridge carrying Trafford Road over the Manchester Ship Canal, thence in a northerly direction along the centre of Trafford Road to Robert Hall Street, thence in an easterly direction along the boundary of Ward 8 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 10, otherwise Docks Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point in the centre of the Swing Bridge carrying Trafford Road over the Manchester Ship Canal and passing thence in a north-westerly direction along the County Borough Boundary to the easterly side of Mode Wheel Locks, thence along an imaginary straight line drawn in a northerly direction to Cemetery Road, thence along the centre of Cemetery Road to Eccles New Road, thence in a westerly direction along the centre of Eccles New Road to Derby Road, thence along the centre of Derby Road to the centre of the Bridge carrying Derby Road over the London and North Western Railway (main line) and thence in an easterly direction along the centre of the London and North Western Railway (main line) to a point under the centre of Cross Lane, thence in a southerly direction along the boundaries of Wards 7, 8 and 9 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 11, otherwise St. Thomas' Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point in the

centre of Cross Lane opposite the centre of Ellor Street and passing thence in a north-westerly direction along the centre of Ellor Street to Florin Street, and continuing in a westerly direction along the centre of Ellor Street to Church Street, thence in a northerly direction along the centre of Church Street to Broad Street, thence in a westerly direction along the centre of Broad Street and Eccles Old Road to Langworthy Road, thence in a northerly direction along the centre of the unnamed passage leading to Bolton Road opposite Charles Street, thence along the centre of Charles Street and Laundry Street to the boundary of Ward 1, thence in a south-easterly and north-easterly direction along the boundary of Ward 1 to the boundary of Ward 5, thence in a southerly direction along the boundary of Ward 5 to the boundary of Ward 7, thence in a westerly direction along the boundary of Ward 7 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 12, otherwise St. Paul's Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point in the centre of Cross Lane on the Bridge over the centre of the London and North Western Railway (main line) and passing thence in a westerly direction along the boundary of Ward 10 to a point opposite the centre of Athole Street, and thence along an imaginary straight line drawn in a northerly direction to Athole Street, thence along the centre of Athole Street and Fitzwarren Street to Clarendon Road, thence in an easterly direction along the centre of Clarendon Road to Florin Street, thence along the centre of Florin Street to Ellor Street, thence in a south-easterly direction along the centre of Ellor Street to the boundary of Ward 7, thence in a southerly direction along the boundary of Ward 7 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 13, otherwise Langworthy Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point in the centre of Ellor Street opposite Florin Street and passes thence in a southerly direction along the boundary of Ward 12 to the boundary of Ward 10, thence in a westerly direction along the boundary of Ward 10 to Langworthy Road, thence in a northerly direction along the centre of Langworthy Road to its junction with Eccles Old Road, thence in an easterly direction along the centre of Eccles Old Road and the boundary of Ward 11 to the point of commencement aforesaid.

" And I do hereby determine that the said Ward No. 14, otherwise Seedley Ward, shall comprise so much of the area of the County Borough of Salford as is contained within a line commencing at a point in the centre of Eccles Old Road opposite the centre of Langworthy Road and passing thence in a southerly direction along the boundary of Ward 13 to the boundary of Ward 10, thence in a westerly direction along the boundary of Ward 10 and continuing in the centre of the London and North Western Railway (main line) to a point under the Bridge carrying Weaste Road over the Railway thence in a northerly direction along the centre of Weaste Road and Weaste Lane to Eccles Old Road, thence in an easterly
