BLACKBURN ELECTRIC LIGHTING (EXTENSION).

OTICE is hereby given, that the Mayor, Alderman and Burgesses of the county Dorough of Blackburn (hereinafter referred to as "the Corporation"), whose address is the Town Hall, Blackburn, have applied to the Electricity Commissioners under the Electricity (Supply) Acts, 1882 to 1919, for a Special Order (hereinafter referred to as "the Order") for all or some of the following purposes (that it is nearly that it is a serious content of the country of the state of the serious of the

1. To extend the area for the supply of electrical energy by the Corporation so as to enable them to provide and distribute electrical energy for all public and private purposes as defined by the Electricity (Supply) Acts, 1882 to 1919, within the urban districts of Rishton and Great Harwood and the parishes of Wilpshire, Clayton-le-Dale and Rams-greave, in the rural district of Blackburn, all in the county of Lancaster (hereinafter referred to as the "added area"), and to provide that where the boundary of the added area is a street or road the Corporation may supply electrical energy to houses and premises on both

sides of such street or road.

2. To authorise the Corporation to exercise all powers usually conferred upon distributors of electrical energy, and to sell electric lines,

fittings, apparatus and appliances.

3. To authorise the Corporation to enter into and carry into effect agreements with any local authority, company or person for the supply of electrical energy in bulk by such local authority, company or person to the Corpora-

4. The names of the streets in which it is proposed that electric lines shall be laid down within a period to be specified by the Order

(a) In the Urban District of Great Harwood.—Towngate; Blackburn Road from Towngate to Rushton Street; Church Street from Towngate to Britannia Street; Queen Street from Towngate to St. Hubert Street;

Glebe Street.

(b) In the Urban District of Rishton.-Brook Street from Harwood Road for a distance of 100 yards; Blackburn Road from Harwood Road to opposite Cricket Ground; Harwood Road from High Street to Stourton Street; High Street; Hermitage Street from junction of High Street to Parker Street.

(c) In the Rural District of Blackburn.—Parish of Wilpshire.—Whalley New Road from Ribchester Road to a point 220 yards north; Ribchester Road from Whalley New Road to the parish

boundary.

Parish of Clayton-le-Dale.—Ribchester Road from Somerset Avenue to Knowsley Road; Knowsley Road from Ribchester Road for a distance of 200

yards.

Parish of Ramsgreave.—Ramsgreave Road from Whalley New Road for a distance of 365 yards; Pleckgate Road from Whalley New Road for a distance of 300 yards.

5. The streets and parts of streets not repair. able by the local authority (including roadways over bridges and the approaches thereto) and railways (including level crossings) and tramways which the Corporation propose to take special powers to break up are:-
