Treaty.

By the Treaty, the High Contracting Powers have agreed that their courts and authorities shall render to the Tribunal direct all the assistance in their power, particularly as regards transmitting notices and collecting evidence; and they have also agreed to regard

the decisions of the Tribunal as final and conclusive and to render them binding upon their nationals.

The British Government has provided headquarters for the Tribunal in Winchester House, 21, St. James's Square, S.W. 1. Mr. Claude Mullins, barrister-at-law, is the British Secretary.

TOBACCO TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES (AS FIXED AND AS VARIED) FOR MALE AND FEMALE APPRENTICES IN THE CIGAR SECTION OF THE TRADE.

Effective as from 1st September, 1921.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in any case not later than 7th September, 1921.
