## FINANCE ACT, 1921.

In pursuance of the provisions of section 49 (2) of the Finance Act, 1921 (11 and 12 Geo. 5, c. 32), the Lords Commissioners of His Majesty's Treasury have given directions that where any dividend due on any sum of stock to which that section applies is not claimed within a period of five years from the date on which it accrued due or a period of one year from the date on which the stock matures, whichever is the shorter, the dividend so unclaimed shall be paid to the National Debt Commissioners in compliance with the section.
