tion of any annual or other money payment to be made by us to such Corporation:

"And whereas the Subchanter and Vicars Choral of the Cathedral Church of Lichfield constitute a Corporation aggregate within the meaning of the said hereinbefore recited Act, and have agreed with us that with the view of effecting such a transfer of certain hereditaments now belonging to them as is contemplated by the said Act, the following arrangement shall be recommended by us to Your

Majesty in Council:

Now, therefore, with the consent of the said Subchanter and Vicars Choral of the Cathedral Church of Lichfield, testified by their having hereunto affixed their Corporate Seal, and of the Right Reverend John Augustine, Lord Bishop of Lichfield, Visitor of the said Corporation (in testimony whereof he hath hereunto set his hand and affixed his Episcopal Seal), we humbly recommend and propose that immediately upon the gazetting of any Order of Your Majesty in Council ratifying this Scheme, and without any Conveyance or Assurance in the law other than such duly gazetted Order, the houses and premises particulars whereof are set forth in the Schedule hereunder written now belonging to the said Subchanter and Vicars Choral with their appurtenances and all the estate right, title and interest in the same of the said Subchanter and Vicars Choral, be, for the consideration hereinafter mentioned, transferred by and from the said Subchanter and Vicars Choral to us, and shall then and thereupon become and be absolutely vested in us and our successors, for the purposes of the Acts relating to us, and subject to the provisions of the same Acts, and that we shall upon such gazetting as aforesaid be entitled to the rents, profits and proceeds of the said hereditaments hereby proposed to be transferred to us as from the twenty-fourth day of June, One thousand nine hundred and twenty-one, and that in conaideration of and for such transfer there shall be paid by us to the said Subchanter and Vicars Choral the sum of One hundred pounds per annum by equal quarterly payments on the twenty-fifth day of March, the twenty-fourth day of June, the twenty-ninth day of September, and the twenty-fifth day of December in every year: and that immediately upon such gazetting as aforesaid, payment shall be made by us to the said Subchanter and Vicars Choral of the amount which by virtue of the provision hereinbefore contained will then be due in respect of so many complete periods of three months as shall then have elapsed since the said twenty-fourth day of June, One thousand nine hundred and twenty-one:

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said Act or of any other Act

of Parliament."

"The Schedule to which the foregoing Scheme has reference.

"All those eleven houses situate in 'The Close' and 'Vicars Close' in the City of Lichfield in the County of Stafford, and being House No. 5, 'The Close,' in the occupation of Miss Russell; also No. 6, 'The Close,' next thereto, in the occupation of Miss Astbury;

also No. 10, 'The Close,' in the occupation of C. W. Fredericks or his under-tenants; also the House No. 1, 'Vicars Close,' in the occupation of Mrs. Baker; also the House next adjoining being No. 2, 'Vicars Close,' in the occupation of Mrs. Morecroft; also the House next adjoining being No. 3, 'Vicars Close,' cocupied by Miss Gething; also the House No. 6, 'Vicars Close,' in the occupation of D. Harrison; also the House next but one thereto, being No. 8, 'Vicars Close,' in the occupation of F. Salloway; also the House next adjoining being No. 9, 'Vicars Close,' in the occupation of Miss Attwood; also the House next adjoining being No. 10, 'Vicars Close,' in the occupation of Mrs. George or her sub-tenants; also the House next adjoining being No. 11, 'Vicars Close,' in the occupation of Miss George, together with yards or gardens adjoining the said houses, or occupied therewith, and the ways and passages leading thereto and the rights of way over adjoining properties.''

And whereas the said Scheme has been ap-

proved by His Majesty in Council: .

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the Diocese of Lichfield.
