THE ROADS ACT, 1920.

COUNTY BOROUGH OF BURNLEY.

Whereas by sub-section (4) of Section 7 of the Roads Act, 1920, it is enacted that the Minister may, by order on the application of any county council (as defined in Section 17 of the Act), after holding a public inquiry, prohibit or restrict, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of vehicles of any specified class on any specified highway within the area of the council in any case in which it appears to him, as the result of the inquiry, to be proved that a vehicle of that class cannot be used on that highway without endangering the safety of the vehicle or the persons therein or of other traffic using the highway, or that the highway is unsuitable for use by a vehicle of that class;

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 20TH OCTOBER 1921.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1. The restrictions on movement of swine imposed by the Swine-Fever (Regulation of Movement) Order of 1908 and the Suffolk (Swine Fever) Order of 1914 shall not apply to the movement of swine from the sale mentioned in the Schedule hereto to any premises in Great Britain not being a Swine-Fever Infected Place, if the swine are accompanied by a licence in the Form F set forth in the First Schedule to the said Order of 1908, granted by an Inspector of the Local Authority of the borough of Bury St. Edmunds, and the following conditions, which shall be specified in the licence, are complied with:—

(i) The swine shall be moved to the place of destination specified in the licence and not elsewhere, and shall be there detained and kept separate from all other swine
