TRADE BOARDS ACTS, 1909 AND 1918.
DRESSMAKING AND WOMEN'S LIGHT CLOTHING TRADE BOARD (SCOTLAND).

PROPOSAL TO VARY MINIMUM RATES FOR CERTAIN CLASSES OF FEMALE WORKERS IN THE RETAIL BRANCH OF THE TRADE IN CERTAIN AREAS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October, 1918, the Trade Board established under the Trade Boards Act, 1918, and the Trade Boards (Women's Clothing) Order, 1919, for the Dressmaking and Women's Light Clothing Trade in Scotland, as defined in the Regulations made by the Minister of Labour and dated 29th March, 1920, as varied by the Trade Boards (Shirtmaking Order), 1920, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary the General Minimum Time-Rates and Overtime Rates for Certain Classes of Female Workers in the Retail Branch of the trade at present fixed and set out in the Schedule to their Notice W.D.S. (6) dated 28th September, 1921, in their application to certain areas, the proposed General Minimum Time-Rates and Overtime Rates for such Female Workers in the areas specified in Part I of the Schedule to this Notice being as shown in such Schedule.

The Minister of Labour has given his consent to the issue of this Notice of Proposal.

SCHEDULE.

PART I.

Proposed Variation of General Minimum Time-Rates and Overtime Rates for Certain Classes of Female Workers in the Retail Branch of the Trade in the following area, viz.:—The whole of Scotland *except* (a) Royal, Parliamentary and Police Burghs which had according to the most recent Census a population over 12,000; and (b) the following Special Lighting Districts, the boundaries of which have been defined, viz.:—Bellshill and Mossend, Blantyre, Cambuslang and Larkhall, all in the County of Lanark and Vale of Leven in the County of Dumbarton.

SECTION I.—Female Workers (other than Learners as defined by the Trade Board):—

SECTION II.—Female Learners as defined by the Trade Board:—

Learners commencing at 15 and under 17 years of age, during their 5th year of employment: At present fixed, 9d. per hour. Proposed, 8½d. per hour.
