**W**HEREAS in pursuance of the powers conferred on Him by the Treaties of Peace (Austria and Bulgaria) Act, 1920, His Majesty in Council was pleased to make the India Treaty of Peace (Austria) Order, 1921, and it is expedient that the said Order shall be amended in manner hereinafter appearing:

And whereas His Majesty is satisfied that the Legislatures of the territories which are under His Majesty's protection hereinafter mentioned have made reciprocal provisions for the enforcement within those territories of judgments obtained in the High Court in England, the Court of Session in Scotland and the High Court in Ireland:

Now, therefore, His Majesty, by virtue and in exercise of the powers by the above-recited Act in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. The provisions of the India Treaty of Peace (Austria) Order, 1921, set out in the first column of the Schedule to this Order shall be amended in the manner shown in the second column of that Schedule.

2. This Order may be cited as the India Treaty of Peace (Austria) (No. 2) (Amendment) Order, 1921, and the India Treaty of Peace (Austria) Order, 1921, and this Order may be cited together as the India Treaty of Peace (Austria) Orders, 1921.
