

of a supply of gas laid on for standby purposes to premises having a separate supply of electricity or gas.

To relieve the Company from the obligation to supply gas for all or any purposes from any main of which the capacity is insufficient or so as to interfere with the sufficiency of the gas required for lighting or domestic purposes.

To require consumers to pay to the Undertakers the expenses of reconnecting any supply of gas cut off in consequence of the default of the consumer.

To authorize the Undertakers to vary the prices charged for gas according to the purposes for which it is supplied.

To authorize the Directors of the Undertakers to prepare, put in force, modify, alter and rescind schemes enabling all or some of their employees to participate in the profits of the undertaking and to provide for the issue of shares or stock to employees at the request of the Trustees under any such scheme without first offering such shares or stock for sale by public auction or tender, and if thought fit to make and prescribe regulations with reference to stock or money belonging to any person or to which any person may be entitled under the terms of any such scheme as aforesaid and to any money deposited with the Undertakers by any person in their employment otherwise than under any such scheme.

To provide that notwithstanding anything in the Companies Clauses Consolidation Act, 1845, no person shall be disqualified from being a director of the Undertakers by reason of his holding any office or place of trust or profit under the Undertakers or by reason of his being interested in any contract with the Undertakers, and that no director shall be required to cease from voting or acting as a director by reason of his accepting any such office or place of trust or profit or becoming interested in any such contract.

To empower the Directors of the Undertakers to appoint and remunerate a managing director or managing directors and to delegate powers to him or them and to provide that a managing director shall not be subject to retirement by rotation.

To empower the Directors of the Undertakers to appoint as a Director any Chief Engineer, General Manager or Secretary of the Undertakers, and for that purpose to increase the prescribed number of Directors and to provide that any Director so appointed shall not be subject to retirement by rotation.

To provide for and require the giving of notice of intention to propose any person for election as a Director of the Undertakers and of opposition to the re-election of any retiring Director and to make provisions as to the qualification of Directors.

To authorize the Directors of the Undertakers to grant pensions or allowances or other payments to employees of the Company or the widow or family or dependants of any such employee, and to enter and carry into effect agreements with insurance companies or others for securing such payment.

To authorize the Directors of the Undertakers to subscribe or make donations to funds raised in case of national emergency or to infirmaries, hospitals and convalescent homes and other institutions and objects or to the benevolent or sick funds of the employees of the Undertakers.

To authorize the Company to form out of revenue as part of their working expenses a Special Purposes Fund to be applicable to meet expenses incurred by reason of accidents, strikes or circumstances which, due care and management could not have prevented or expenses incurred in the replacement or removal of plant or works, and to provide for the amalgamation with that fund of the existing insurance fund of the Undertakers.

To repeal section 77 of the Truro Gas Act, 1906, and to prescribe a new sliding scale of price and dividend.

To empower the Undertakers to enter premises and remove therefrom pipes, meters, fittings and apparatus in cases where a person entering into occupation of the premises does not require to take a supply of gas from the Undertakers or to hire the pipes, meters, fittings or apparatus of the Undertakers.

To require persons using air at high pressure in connection with the consumption of gas supplied by the Undertakers to provide, fix, maintain and use a valve or other appliance for preventing the admission of such air into any service pipe or main, and to empower the Undertakers to discontinue the supply of gas in case of non-compliance with the intended provisions or any requirement thereunder, and to enter and inspect premises and remove and test valves and appliances.

The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.

To repeal, alter or amend all or any of the provisions of the Truro Gas Act, 1906, and any other Act or any Order relating to the Undertakers.

To incorporate with the Order with or without modifications or to render inapplicable all or some of the provisions of the Companies Clauses Consolidation Acts, 1845 to 1889, the Gas Works Clauses Act, 1847, and the Gas Works Clauses Act, 1871.

Printed copies of the draft Order will be deposited for public inspection with the Clerk of the Peace and County Council for the county of Cornwall, at his office at the County Hall, Truro, and with the Town Clerk of the city of Truro, at his office at 29, River-street, Truro, and printed copies of the draft Order may be obtained at the offices of the Undertakers and of the undermentioned Parliamentary Agents at the price of two shillings for each copy.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Secretary, Board of Trade, Great George-street, London, S.W. 1, and despatched on or before the 19th day of December, 1921.

Any such objection must state: (a) The specific grounds of objection, and (b) the omissions, additions or modifications asked for, and a copy thereof must at the same time be forwarded to the Undertakers or to the under-signed Parliamentary Agents.
