WATER UNDERTAKINGS (MODIFICATION OF CHARGES) ACT, 1921.

NOTICE is hereby given, that the Maidstone Waterworks Company have made application to the Minister of Health under the above Act for an Order modifying Sections 22, 24 and 31 of the Maidstone Waterworks Act, 1860, to enable them to increase the charges for water supplied under the terms of those sections by one-sixth, and modifying Sections 47 and 48 of the Maidstone Waterworks Act, 1860, to enable them to make charges for water supply for domestic purposes in the water limits within which they are empowered to supply water, in accordance with the following scale:—

Annual value not exceeding £7, 10s. per annum.

Annual value of £7, but not exceeding £8, 11s. per annum.

Annual value of £8, but not exceeding £9, 12s. per annum.

Annual value of £9, but not exceeding £10, 14s. per annum.

Annual value of £10, but not exceeding £11, 15s. per annum.

Annual value of £11, but not exceeding £12, 16s. per annum.

Annual value of £12, but not exceeding £13, 18s. per annum.

Annual value of £13, but not exceeding £14, 19s. per annum.

Annual value of £14, but not exceeding £15, 21s. per annum.

Annual value of £15, but not exceeding £16, 22s. per annum.

Annual value of £16, but not exceeding £17, 23s. per annum.

Annual value of £17, but not exceeding £18, 25s. per annum.

Annual value of £18, but not exceeding £19, 26s. per annum.

Annual value of £19, but not exceeding £20, 28s. per annum.

Annual value of £20, but not exceeding £25, 32s. per annum.

Annual value of £25, but not exceeding £30, 36s. per annum.

Annual value of £30, but not exceeding £35, 41s. per annum.

Annual value of £35, but not exceeding £40, 47s. per annum.

Annual value of £40, but not exceeding £45, 52s. per annum.

Annual value of £45, but not exceeding £50, 58s. per annum.

Annual value of £50, but not exceeding £60, 66s. per annum.

Annual value of £60, but not exceeding £70, 74s. per annum.

Annual value of £70, but not exceeding £80, 82s. per annum.

Annual value of £80, but not exceeding £95, 90s. per annum.

Annual value exceeding £95, 4½ per cent. per annum.

One additional Water-closet beyond the first, 9s. per annum.

Each additional Water-closet beyond the second, 6s. per annum.

Each Bath, where annual value does not exceed £15, 6s. per annum.

First Bath, where annual value exceeds £15, 9s. per annum.

Each additional Bath, where annual value exceeds £15, 6s. per annum.

Each Water-closet supplied separately from premises charged upon annual value, 24s. per annum.
