

application to the Minister of Health for the issue of a Provisional Order under sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter or amend the Margate Corporation Act, 1900, the Margate Corporation Act, 1908, the Provisional Order relating to Margate confirmed by the Local Government Board's Provisional Orders Confirmation (No. 6) Act, 1884, and the Margate Order, 1894, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 4) Act, 1894, so as:—

(1) To authorise the Corporation to make a scheme for prescribing one or more equated periods within which all or any loans contracted by them under statutory borrowing powers shall be discharged, to provide by such scheme for extending or varying the periods within which such loans shall be discharged, and to make provision in regard to all matters incidental thereto;

(2) To enable the rate of accumulation of the annual contributions to the sinking funds of the Corporation to be altered;

(3) To authorise the Corporation (with the consent of the majority of the owners for the time being) to take over and keep as public gardens or open spaces the pieces of ground known as the Marine Terrace Green and the Hawley Square Gardens, Margate, and to lay out, plant, ornament, improve, manage, control and maintain the said Greens; and

(4) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said local Acts or of any other local Act or Act confirming a Provisional Order made in pursuance of any of the sanitary Acts or of the Public Health Act, 1875, in force in the said borough as may be necessary or desirable;

LEEK.

Whereas the Urban District Council of Leek have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public

Health Act, 1875, to partially repeal, alter or amend the Leek Improvement Act, 1855, so as:—

(1) To increase by an amount not exceeding 100 per cent. the tolls, stallages, rents and payments which the Council are empowered to demand and take in respect of their markets and fairs as set out in Schedule (A) to the said Local Act; and

(2) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Urban District as may be necessary or desirable;
