## ST. ANNE'S INDUSTRIAL SCHOOL FOR ROMAN CATHOLIC GIRLS.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment of women and young persons of 16 years of age and over in the manufacture of golf balls at the works of the India Rubber, Gutta Percha and Telegraph Works Co., Ltd., Silvertown, E. 16, on two day-shifts, subject to the conditions that no worker shall be employed in the afternoon shift in consecutive weeks, that suitable protective clothing shall be provided for the workers engaged in painting, centre filling and mixing material for the centres; and that a responsible welfare supervisor shall be appointed who shall be responsible for the supervision of the workers employed under this Order and of the welfare accommodation provided for their use.
