PART V.

Section I.—The above General Minimum Time-Rates and Overtime Rates shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act, to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

Section II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages, to workers of greater skill or length of experience, or to Agreements made or that may be made between employers and workers for the payment of wages in excess of these Minimum Rates of Wages.

Signed by Order of the Trade Board and in pursuance of an Order of the Minister of Labour confirming the Minimum Rates as varied by the Trade Board and set out above and specifying the 1st day of February, 1922, as the date from which they should become effective.
