The following Statute made by the Governing Body of Lincoln College, Oxford, on the 1st day of February, 1922, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877."

STATUTE amending the Statutes of Lincoln College, Oxford, passed unanimously at a meeting of the Rector and Fellows of the College specially summoned for the purpose on the 1st February, 1922:—

"In cap. 7 to add the following section:-

"§ 3. Having regard to the effect of the late war in retarding the repairs on estates and enhancing the cost of such repairs, the Rector and Fellows shall have power, notwithstanding any provision to the contrary in the Statutes of the College, to postpone until any date not later than three years after the end of the Emergency period created by the Universities and Colleges (Emergency Powers) Act, 1915, the election or admission to any Fellowship or Fellowships other than that attached to the Professorship of Classical Archæology and Art, provided that the emoluments of such Fellowship or Fellowships be applied exclusively to the maintenance and improvement of the estates of the College."

TENDERS FOR LOANS ON TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 17th February, 1922, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914 to 1919, to the amount of £30,000,000.
- 2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any date from Monday, the 20th February, to Saturday, the 25th February, inclusive, and will be payable at three months after date.
- The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.
- 7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
