

signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parish of Wimborne Minster which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Stephen, Kingston Lacy, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Stephen, Kingston Lacy.'

"And with the like consent of the said St. Clair George Alfred, Bishop of Salisbury (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said Church of Saint Stephen, Kingston Lacy, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Stephen, Kingston Lacy, being:—

"All that part of the Parish of Wimborne Minster, in the County of Dorset and in the Diocese of Salisbury, which is bounded upon part of the south east by the Parish of Canford Magna, upon the South by the Parish of Corfe Mullen, upon the south west by the Parish of Sturminster Marshall, upon the west by the Parish of Shapwick, upon the north west by the Parish of Tarrant Rushton, upon the north by a detached portion of the Parish of Witchampton, all in the said County and Diocese, upon a small part of the north east by a detached portion of the said Parish of Shapwick, and upon the remaining sides, that is say, upon the remaining part of north east and upon the remaining part of the south east, by an imaginary line commencing upon the boundary which divides the said detached portion of the Parish of Shapwick from the said Parish of Wimborne Minster at Paternoster Cross at the junction of the old Roman Road with the roadway leading across King Down, and extending thence south eastward along the middle of the said roadway for a distance of 1 mile or thereabouts to its junction with Barnsley Road and with the road leading to Chillbridge, and extending thence south eastward along the middle of the last-mentioned road for a distance of 59 chains or thereabouts to the point opposite to the south western end of the fence which divides the close numbered 1938 on the Tithe Map of the Parish of Wimborne Minster and also on the map or plan annexed to this Representation from the close numbered 1937 on the same maps, and extending thence first north eastward to the said fence and then first north eastward and then in various directions along the fences which divide the said close numbered 1938 and

the closes numbered 1933 and 1931 on the said maps from the said close numbered 1937 and the closes numbered 1934 and 1911 on the said maps for a distance in all of 38 chains or thereabouts to the point where the fence which divides the said close numbered 1931 from the said close numbered 1911 reaches the western bank of the stream which flows from near Lower Barnsley Farm House into the River Allen, and extending thence first eastward to the middle of the said stream and then first south-eastward and then in various directions along the middle of the same stream for a distance of 1 mile or thereabouts to its junction with the River Allen, and extending thence first south eastward then southward and then again south eastward along the middle of the said river for a distance of 42 chains or thereabouts to a point opposite to the north eastern end of the fence forming the south eastern boundary of the close numbered 1826 on the said maps and extending thence first south westward to and along the said fence and then first south eastward and then southward along the fence forming the eastern boundary of the close numbered 1848 on the said maps for a distance in all of 18 chains or thereabouts to the point where the last-mentioned fence meets the fence on the northern side of Stone Lane, and extending thence first southward to and then westward along the middle of Stone Lane for a distance of $8\frac{1}{2}$ chains or thereabouts to its junction with the roadway connecting Stone Lane with the road leading from Blandford to Wimborne, and extending thence south westward along the middle of the said roadway for a distance of 3 chains or thereabouts to its junction with the said road leading from Blandford to Wimborne, and extending thence south eastward along the middle of such road for a distance of 3 chains or thereabouts to its junction with the lane leading past Stone Farm House, and extending thence first south westward and then in various directions along the middle of the said lane for a distance of 17 chains or thereabouts to the point opposite to the northern end of the fence forming the western boundary of the premises attached to Stone Farm House, and extending thence south westward along the last-mentioned fence for a distance of $2\frac{1}{2}$ chains or thereabouts to the point where it crosses the roadway leading from the said farmhouse to Pamphill, and extending thence first north westward then south westward and then again north westward along the middle of the last-mentioned roadway for a distance of $10\frac{1}{2}$ chains or thereabouts to a point opposite to the north eastern end of the fence forming the north western boundary of the close numbered 2147 upon the said maps, and extending thence first south westward to and along the last-mentioned fence and then first southward and then south eastward along the fence forming the western boundary of the close numbered 2145 upon the same maps for a distance in all of 12 chains or thereabouts to the southern end of the last-mentioned fence on the northern side of the road leading from Wimborne Minster to Cowgrove, and extending thence first south eastward to the middle of the last-mentioned road and then south westward along the middle of such road for a distance in all of $3\frac{1}{2}$ chains or thereabouts to a point opposite to the northern end of the fence forming the western boundary of the close numbered 2180 upon the said maps, and extending thence south westward first to and along the last-men-
