the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of Patronage of and presentation to the said Benefice of Stepleton Iwerne, now vested in her the said Gertrude Emily Pitt as aforesaid, shall be transferred to the said St. Clair George Alfred, Bishop of Salisbury, and his successors in the Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said St. Clair George Alfred, Bishop of Salisbury, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them in accordance with the provisions of the said Acts, or of any of them,

or of any other Act of Parliament."

And whereas the said Scheme has been ap-

proved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Salisbury.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 2nd day of September, 1858, and published in the London Gazette on the 10th day of the same month, part of the District Parish of the Holy Trinity, Trowbridge, in the said County of Wilts and in the said Diocese of Salisbury, was assigned as a District Chapelry to the consecrated Church of Saint John, situate at Studley, in the said District Parish of the Holy Trinity, Trowbridge, and the said District Chapelry was named 'The District Chapelry of Saint John, Studley':

"And whereas the said District Chapelry

"And whereas the said District Chapelry of Saint John, Studley, has under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish, of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty,

Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parish of Saint John, Studley, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend St. Clair George Alfred, Bishop of Salisbury (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint John, Studley, shall be altered so that all that portion of the said District Parish of the Holy Trinity, Trowbridge, which is described in the Schedule hereunder written and is delineated and set forth upon the Map or Plan hereunto annexed and is thereon coloured pink, shall be dissevered from such District Parish and shall be annexed to and shall in future form part of the said New Parish of Saint John, Studley.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"The territory to be annexed to the New Parish of Saint John, Studley, in the County of Wilts and in the Diocese of Salisbury, being:—

"All that portion of the District Parish of the Holy Trinity, Trowbridge, in the said County and Diocese, which is bounded upon part of the south east and upon the south west by the said New Parish of Saint John, Studley, and upon the remaining sides, that is to say, upon the north, upon the north east and upon the south east by an imaginary line commencing upon the boundary, which divides the said New Parish of Saint John, Studley, from the said District Parish of the Holy Trinity, Trowbridge, at the northern end of the fence which divides the close numbered 244 upon the Ordnance Map of the Civil Parish of Trowbridge published in the year 1901 upon the scale of 25 inches to a mile and also upon the map or plan which is annexed
