

At the Court at *Buckingham Palace*, the 3rd day of *March*, 1922.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 2nd day of February, 1922, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Andrew, situate at Barnt Green, in the New Parish (sometime Consolidated Chapelry) of The Lickey, in the County of Worcester and in the Diocese of Birmingham:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Andrew, situate at Barnt Green as aforesaid:

"Now, therefore, with the consent of the Right Reverend Henry Russell, Bishop of Birmingham (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said New Parish of The Lickey which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Andrew, situate at Barnt Green, as aforesaid, and that the same should be named 'The District Chapelry of Saint Andrew, Barnt Green.'

"And with the like consent of the said Henry Russell, Bishop of Birmingham (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Andrew, situate at Barnt Green, as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings, and burials should be paid and belong to the Minister of the same church for the time being.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Andrew, Barnt Green, being:—

"All that part of the New Parish (sometime Consolidated Chapelry) of The Lickey, in the County of Worcester and in the Diocese of Birmingham, which is bounded upon the north partly by the Parish of Cofton Hackett, in the said County and Diocese, and partly by the Parish of Alvechurch, in the said County of Worcester and in the Diocese of Worcester, upon the north-east and upon the south-east by the said Parish of Alvechurch, upon the south by the Parish of Tardebigge, in the said County of Worcester and in the said Diocese of Worcester, and upon the remaining side, that is to say, upon the west, by an imaginary line commencing upon the boundary which divides the said Parish of Tardebigge from the said New Parish of The Lickey at a point in the road leading from Barnt Green to Blackwell opposite to the middle of the bridge which carries the roadway leading to Gorsebank Cottage across the Bristol and Birmingham line of the Midland Railway and extending thence north-westward first to and along the middle of the said roadway and then along the middle of the footpath leading from the said cottage to Linthurst Road for a distance in all of 40 chains or thereabouts to the point where such footpath joins Linthurst Road, and extending thence first north-westward to and then northward along the middle of Linthurst Road for a distance of  $5\frac{1}{2}$  chains or thereabouts to its junction with Fiery Road and with the western branch of Twatling Road, and extending thence northward along the middle of Twatling Road for a distance of 2 chains or thereabouts to its junction with Cherry Hill Road, and extending thence north-eastward along the middle of Cherry Hill Road for a distance of 25 chains or thereabouts to a point opposite to the fence forming the eastern boundary of Pinfields Wood, and extending thence first north-westward to the said fence and then first north-westward, and then in various directions along the said fence for a distance in all of 25 chains or thereabouts to the point where it meets the southern side of the River Arrow, and extending thence north-eastward in a straight line to the middle of the River Arrow upon the boundary which divides the said New Parish of The Lickey from the said Parish of Cofton Hackett."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Birmingham:
