And to command that the said Royal concession and declaration be recorded in His Majesty's said College of Arms.

SAFETY LAMPS ORDER OF THE 31ST MARCH,
1922.

BRUSH AND BROOM TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY AND FIX MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS FOR PERIODS DEPENDENT ON THE COST OF LIVING INDEX FIGURE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the branches of trade specified in the Trade Boards (Brush and Broom) Order, 1919, HEREBY GIVE NOTICE, as required by Section (3) (5) of the Trade Boards Act, 1918, that they PROPOSE TO VARY (the Minister of Labour having given his consent to such notice being given) the General Minimum Time-Rates, Piece-Work Basis Time-Rates, Guaranteed Time-Rates, General Minimum Piece Rates and Overtime Rates at present effective and set out in the Trade Board's Notices M (26), M (27), M (28), M (29) and M (30) dated 14th December, 1921, and M (32) dated 18th March, 1922, and that they PROPOSE TO FIX General Minimum Piece Rates for the making of certain classes of
