LACE FINISHING TRADE BOARD.

GENERAL MINIMUM TIME RATES (AS VARIED) FOR LEARNERS IN THE MACHINE-MADE LACE AND NET FINISHING TRADE.

Effective as from 5th April, 1922.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in no case later than 11th April, 1922.
