

REDCLIFFE GARDENS,
Old Brompton Road.

Five vehicles.

In two portions, viz. :—

First portion :—Three carriages to stand in centre of roadway, commencing twelve yards South of the lamp-post outside entrance to Coleherne Court, adjoining Williams Deacons Bank, Ltd., and extending towards Redcliffe Square. Front of vehicles Northward.

Second portion :—Two carriages in Redcliffe Square, Kensington, commencing 6 yards from the South side of gateway to enclosure opposite St. Luke's Church, and extend by the kerb Southward as far as necessary. Front of vehicles Northward.

The first portion of the Standing to be fed exclusively from the second portion.

GROSVENOR GARDENS,
S.W. 1.

Three vehicles.

And do make the following Regulations with regard to the boundaries for the same, viz. :—

Commencing at a point opposite the front door of No. 24, Grosvenor Gardens, and extending by the railings of the enclosure as far as necessary for three cabs. Front of vehicles toward the South-east.

HAYMARKET
(North End).

Seven vehicles.

And do make the following Regulations with regard to the boundaries for the same, in two portions, viz. :—

First portion :—Three carriages in the centre of the roadway, commencing opposite No. 34, and extending Southward as far as necessary. Front of vehicles toward the North.

Second portion :—Four carriages in the centre of the roadway, commencing opposite No. 27, and extending Southward as far as necessary. Front of vehicles toward the North.

The first portion to be fed exclusively from the second portion.

UPPER ADDISCOMBE ROAD,
Croydon.

Eight vehicles.

And do make the following Regulations with regard to the boundaries for the same, viz. :—

On the North side of roadway, commencing three yards from the junction of Cherry Orchard Road, and extending Eastward as far as necessary for eight carriages. Front of vehicles toward the West.

THIRLEBY ROAD,
Westminster

Eight vehicles.

And do make the following Regulations with regard to the boundaries for the same, viz. :—

Commencing at the lamp-post at the North corner of the enclosure on the West side of Thirleby Road, Westminster, S.W., and extending along the kerb in a Southerly direction as far as necessary for eight carriages. Front of vehicles toward the North.

EXHIBITION ROAD,
Kensington.

Three vehicles.

And do make the following Regulations with regard to the boundaries for the same, viz. :—

On the West side of roadway, commencing at a point 15 yards from the junction of Kensington Road and Exhibition Road, and extending as far as necessary for three carriages. Front of vehicles toward the North.

QUEEN'S GATE,
(junction of Kensington
Road, Kensington).

Three vehicles.

And do make the following Regulations with regard to the boundaries for the same, viz. :—

In centre of roadway, commencing two yards South of General Napier Statue, and extending as far as necessary for three carriages. Front of vehicles toward the North.

FULHAM ROAD,
Church Street, Chelsea.

Six vehicles.

And do make the following Regulations with regard to the boundaries for the same, viz. :—

Commencing opposite No. 239, and extending Eastward by kerb under the wall of Jews' Burial Ground on South side of road, as far as necessary for six carriages. Front of vehicles toward the West.
