NATIONAL HEALTH INSURANCE ACTS, 1911 to 1921.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon him by Section 4 of the National Insurance (Part I Amendment) Act, 1917, to make regulations providing that a discharged seaman or soldier shall cease to be entitled to any benefits under Article 2 (3) of the National Health Insurance (Discharged Seamen and Soldiers) Regulations, 1918, as from the 30th day of June and the 31st day of December, whichever first occurs, next after the date on which he ceases to be entitled to a pension or an allowance in place of a pension, or the date on which the Minister of Health is notified by the Minister of Pensions that he has ceased to be entitled to such a pension or allowance, whichever is the later.
