

Urban District of Watford shall continue in force within the area of the Borough until revoked or altered by the said County Council.

9. Immediately after the constitution of the Borough an agreement shall be entered into between the Standing Joint Committee of the Quarter Sessions and the County Council of the County of Hertford on the one hand and the Corporation on the other hand for the consolidation of the Police Force of the Borough with the police force of the said County to the intent that no separate police force shall be maintained for the Borough. The terms of the consolidation shall be such as may be agreed between the said parties or as, in default of such agreement, may be determined by one of His Majesty's Principal Secretaries of State.

10. The Council of the Borough shall not exercise any of the powers or duties or be subject to the liabilities in relation to (a) the appointment of Analysts under the Acts relating to the Sale of Food and Drugs or (b) the execution of The Diseases of Animals Acts, 1894 to 1914, and of The Destructive Insects and Pests Acts, 1877 and 1907, or (c) Gas Meters or (d) Weights and Measures, but all the powers duties and liabilities in respect of such matters shall be exercised by and attached to the County Council of the Administrative County of Hertford and the area of the Borough shall for all purposes of the Acts relating to the matters mentioned above form part of the County in like manner as if it were not a Borough.
