Provided always that the Byelaws with respect to New Streets and Buildings in force in the Urban District shall be continued in force in the Borough for a period of one year only after this Scheme has come into operation unless repealed before the expiration of that

period.

13. The Byelaws for the good rule and government of the Administrative County of Hertford, and all Byelaws under the Locomotives Act, 1898 (with respect to the use of locomotives on highways), made by the County Council so far as they are in force in the Urban District of Watford, shall continue in force and be enforced within the Municipal Borough of Watford as if made by the Corporation until the expiration of two years from the commencement of this Scheme or until other Byelaws made by the Corporation and dealing with the same matters (as the case may be) shall have come into force, whichever shall first

14. The Tables of Fees duly allowed and approved in accordance with the provisions of the Burial Acts shall continue in force until the same are repealed varied revised or altered by such bodies and with such approval as is

required by law.

15. The power of the District Council to appoint one representative Trustee of The British School with the Charities of Stewart Marjoribanks and Arthur Ashfield, to appoint one representative Trustee of the Foundation. of Francis Combe, to appoint three representative Trustees of the Charity of Dorothy Lady Morison with the subsidiary Charities of Anni Phrip and Hannah Pocock, to appoint eight representative Governors of The Watford Grammar Schools, and to appoint two representative Trustees of the Charity of George Reveley under the Orders and Schemes hereinbefore recited shall be transferred to and vested in the Corporation without prejudice to the tenure of office of any Trustee or Governor appointed by the District Council in office at the commencement of this Scheme.

From and after the commencement of this Scheme any powers and duties of the District Council under any Order or Scheme made under the War Pensions Acts shall be transferred to the Council of the Borough, and the said Order or Scheme shall remain in force until the same is altered or revoked in pursuance of the said Acts and shall be read as if the Council of the Borough were therein referred to instead of the District Council and the District.

17. The power of the District Council to appoint (with the Watford Rural District two members of the Provincial Council) Council for the County of Hertford under the hereinbefore recited Scheme approved on the 27th day of June, 1921, shall be transferred to and vested in the Corporation (with the Watford Rural District Council) without prejudice to the tenure of office of any members appointed by the two Councils in office at the commencement of this Scheme.

18. The power of the District Council to appoint five Managers for the provided
