Declaration of Prohibited Area and Modification of Restrictions in Scheduled District.

1.—(1) The Area described in the Schedule hereto is hereby declared to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(2) Part III of that Order is hereby applied to the Scheduled District described in the Northumberland and Durham (Foot-and-

Mouth Disease) Order of 1922.

(3) The provisions of Article 2 of the Northumberland and Durham (Foot-and-Mouth Disease) Order of 1922 shall continue to apply to the Prohibited Area, and the provisions of Article 6 of the "principal Order" shall be read and have effect subject to this modification.
