ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

BIRMINGHAM DISTRICT (FOOT-AND-
MOUTH DISEASE) ORDER OF 1922
(No. 7).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Restrictions to Scheduled District.

1. Parts I., III. and IV. of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as "the principal Order," are hereby applied without modification, save as hereinafter provided, to the district described in the Schedule hereto, which shall be a Scheduled District for the purposes of that Order.

Restriction on Granting of Movement Licences.

2. No Licence shall be granted by an Inspector of the Local Authority for the movement of animals into or within the Scheduled District if the intended movement is to or from any premises situate within a radius of two miles of any place which is for the time being declared to be a place infected with Foot-and-Mouth Disease, or if the intended movement would involve movement on a road which is within a radius of two miles of any such place.

Revocation.

3. The Birmingham District (Foot-and-Mouth Disease) Orders of 1922 (Nos. 5 and 6) are hereby revoked.

Commencement.

4. This Order shall come into operation on the eighteenth day of July, nineteen hundred and twenty-two.

Short Title.

5. This Order may be cited as the BIRMINGHAM DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1922 (No. 7).

Scheduled District.

A District comprising:—

In the administrative county of Stafford—
The petty sessional division of Kingswinford and Wordsley (except the parish of Bobbington), and the parish of Swindon, and

In the administrative county of Worcester—

The borough of Stourbridge, the petty sessional division of Stourbridge (except the parish of Belbroughton), and the parish of Wolverley.

WEST LANCASHIRE (FOOT - AND -
MOUTH DISEASE) ORDER OF 1922
(No. 3).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Further Contraction of Scheduled District.

1. The West Lancashire (Foot-and-Mouth Disease) Order of 1922 shall be read and have effect as if the District described in the Schedule to this Order were the Scheduled District for the purposes of that Order, and the Scheduled District to which that Order refers is hereby contracted accordingly.

Modification of Restrictions in Contracted Scheduled District.

2. Part III. of the Foot-and-Mouth Disease (Control of Movement) Order of 1920 is hereby applied to the Scheduled District described in the Schedule hereto, which shall cease to be a Prohibited Area for the purposes of that Order.

Restriction on Granting of Movement Licences.

3. No Licence shall be granted by an Inspector of the Local Authority for the movement of animals into or within the Scheduled District if the intended movement is to or from any premises situate within a radius of two miles of any place which is for the time being declared to be a place infected with Foot-and-Mouth Disease, or if the intended movement would involve movement on a road which is within a radius of two miles of any such place.

Commencement.

4. This Order shall come into operation on the eighteenth day of July, nineteen hundred and twenty-two.
