Note.—In cases where a Female Worker is employed on Piece-Work, each Piece-Rate paid must be such as would yield, in the circumstances of the case, to an ORDINARY WORKER, not less than the Piece-Work Basis Time-Rate applicable as set out in Section I of this Part of this

In cases where Male Workers are employed on Piece-Work, each Piece-Rate paid must be such as would yield, in the circumstances of the case, to an ORDINARY WORKER, not less than the General Minimum Time-Rate applicable as set out in Section II of Part I of this Schedule.

PART III.

OVERTIME RATES FOR MALE AND FEMALE WORKERS.

(ALL AGES.)

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board HEREBY DECLARE THE NORMAL NUMBER OF HOURS WORK IN THE TRADE TO BE follows:

Provided that all hours worked by a worker on Sunday and on Customary Public and Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION II.—The Minimum Rates for Overtime in respect of hours worked by a worker in excess of the declared normal number of hours of work shall be as follows:

(A) FOR WORKERS EMPLOYED ON TIME-WORK.

(1) For the first two hours of Overtime on any day, except Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-QUARTER.

(2) For Overtime after the first two hours of Overtime on any day, except Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Half times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-HALF.

(3) For all time worked on Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be Twice the General Minimum Time-Rate otherwise

applicable, i.e., DOUBLE-TIME.

(4) For all hours worked in any week in excess of 48 the Overtime Rate shall be Oneand-a-Quarter times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-QUARTER, except in so far as higher Overtime Rates are payable under the provisions of paragraphs (2) and (3) of Sub-Section (A) of this Section

The Overtime Rates shall be payable where on any day (not being a Sunday or a Customary Public or Statutory Holiday) the number of hours worked exceeds nine, or, in the case of Saturday, exceeds five, notwithstanding that the number of hours worked

in the week does not exceed 48.

Provided that where it is or may become the established practice of an employer to require attendance only on five days a week, the Overtime Rates shall only be payable on such days after 9½ hours have been worked.

(B) FOR FEMALE WORKERS PLOYED ON PIECE-WORK:-

(i) All Female Workers employed on

Piece-Work shall receive in respect of each hour of overtime worked, IN ADDITION TO PIECE-RATES, each of which would yield, in the circumstances of the case, to an ORDINARY worker, not less than the Piece-Work Basis Time-Rate applicable:

(a) AN AMOUNT EQUAL TO ONE-QUARTER OF THE APPROPRIATE PIECE-WORK BASIS TIME-RATE,

(b) AN AMOUNT EQUAL TO ONE-HALF OF THE APPROPRIATE PIECE-WORK BASIS TIME-RATE, or (c) AN AMOUNT EQUAL TO THE FULL AMOUNT OF THE APPRO-PRIATE PIECE-WORK BASIS TIME-

according as the Overtime Rate which would have been payable under the provisions of paragraph (A) of this Section, if the worker had been employed on Time-Work, were-

(a) TIME-AND-A-QUARTER,
(b) TIME-AND-A-HALF, or
(c) DOUBLE-TIME, respectively.

Note.—The hours which Female Workers, Young Persons and Children are allowed to work are subject to the provisions of the Factory and Workshop Acts, and of the Employ-ment of Women, Young Persons and Children Act, 1920.

PART IV.

Subject to the provisions of the Trade Boards Acts, the respective Minimum Rates of Wages set out in this Schedule apply to all Male and Female Workers in Great Britain in respect of all time during which they are employed in any branch of the Trade specified in the Trade Boards (Sack and Bag) Order, 1920, that is to

say:—
The making from woven fabrics of corn sacks, flour sacks, coal sacks, sugar sacks, cement bags, sand bags, nail bags, potato bags, seed bags and similar sacks or bags, or the repairing thereof: including:

(A) The following and similar operations (whether performed by hand or machine) known in the trade as:-

(i) folding (or hooking), cutting, machining, turning;

(ii) brushing, selecting, mending;

(iii) branding, tarring, bundling;

(B) The warehousing of, the packing of, and similar operations in regard to sacks or bags of the kind mentioned above when carried on in association with or in conjunction with the making or repairing thereof;

(C) The warehousing of, the packing of, and similar operations in regard to any other articles when carried on in or in association with or in conjunction with any business, establishment, branch or department mainly engaged in any of the operations mentioned in paragraph (B) above;

but excluding:-

(i) any of the operations mentioned above
