FOOD CONTROL.

Order dated 1st September, 1922, amending the Sale of Food Order, 1921, made by the Board of Trade, under the Ministry of Food (Continuance) Act, 1920 (10 & 11 Geo. 5, c. 47), the Ministry of Food (Cessation) Order, 1921, and the Expiring Laws Act, 1922.

In exercise of the powers conferred upon them by the Ministry of Food (Continuance) Act, 1920, the Ministry of Food (Cessation) Order, 1921, the Expiring Laws Act, 1922, and of all other powers enabling them in that

behalf, the Board of Trade hereby revoke, as on the 15th September, 1922, Part III of the Sale of Food Order, 1921, so far as it relates to bacon and ham.
